- Quarterly EBITDA grows 35% over prior year to \$440 million and operating profit increases 51% to \$324 million - EPS more than doubles to \$0.76; adjusted EPS increases 38% to \$0.69 - Revenues rise 24% - driven by a 93% increase in Australia revenues - Australia EBITDA rises 75% to \$224 million

rose 24%, driven by a 33% increase in Australia revenues - Australia EBITDA rose 73% to \$227 million on higher volumes and pricing - New five-year \$2 billion credit facility completed, incurring \$9.3 million in charges - Raising midpoint of full-year EBITDA and EPS targets
